Notice Concerning Change of Accounting Auditor

Broadmedia Corporation (hereinafter referred to as "the Company") announces that its Board of Auditors passed a resolution on a change to the accounting auditor that conducts the audit certification according to the provisions of Paragraphs 1 and 2, Article 193 -2 of the Financial Instruments and Exchange Act at a meeting held on May 18, 2022, and its Board of Directors resolved at a meeting held today to submit this proposal to the 26th Ordinary General Meeting of Shareholders scheduled to be held on June 24, 2022 as the "Election of Accounting Auditor". appropriate as accounting auditor of the Company.

The term of appointment of Jinchi Audit Corporation, which is the accounting auditor of the Company, will expire upon the closing of the 26th Ordinary General Meeting of Shareholders to be held on June 24, 2022. Accordingly, HLB Meisei LLC is hereby appointed as a candidate for the Company's accounting auditor for the reasons stated in 3 above.
