In addition, from the viewpoint of strengthening corporate governance through the enhancement of the supervisory function of the Board of Directors, the Company transitioned to a Company with an Audit and Supervisory Committee based on an approval at the 28th Ordinary General Meeting of Shareholders held on June 27, 2024. Furthermore, at a meeting held today, the Board of Directors resolved to establish a Nomination and Compensation Committee, the majority of which will consist of Outside Directors, as a voluntary advisory body to the Board of Directors for the purpose of increasing the fairness, objectivity and transparency of procedures for the nomination and compensation of Directors, as well as enhancing corporate governance.
